**Independent Auditor's Report  
To The Board of Trustees of University of Liberal Arts Bangladesh**

**Opinions**

We have audited the Financial Statement of **University of Liberal Arts Bangladesh** which comprises the Statement of Financial Position as at 30<sup>th</sup> June, 2022 and Statement of comprehensive Income, Statement of Changes in Equity and Statement of Cash Flow for the period ended 30<sup>th</sup> June, 2022 and a summary of significant accounting policies and other explanatory notes.

In our opinion, the accompanying Financial Statements give a true and fair view of the Financial Position as at 30<sup>th</sup> June 2022 and its financial performance and its Cash Flows for the period then ended in accordance with the private university financial reporting (PUFR) format as required by Private University Act, 2010 and International Financial Reporting Standards (IFRSs) and comply with other applicable laws and regulation.

**Basis for Opinion**

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those Standards are further described in the Auditors Responsibilities for the audit of the Financial Statements section of our reports. We are independent of the company in accordance with the International Ethics Standards Board for Accountants, Code of Ethics for Professional Accountants (IESBA Code) and we have fulfilled our ethical responsibilities in accordance with the IESBA Code and The Institute of Chartered Accountants of Bangladesh (ICAB) bye Laws. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinions.

**Key Audit Matters**
